

**IMPORTANT DISCLOSURE:
Payroll Tax Payment Verification Methods**

At least quarterly, Maine law requires Bangor Payroll to clearly disclose to each employer (“you”) for which it provides payroll processing services the specific method whereby you can contact state and federal tax and unemployment insurance authorities to verify that payments have been made and properly credited on your behalf. You are legally responsible for the timely filing and payment of employment tax and tax returns even if you have authorized a third party to file returns and make the payments.

The IRS recommends that employers enroll in the Electronic Federal Tax Payment System (EFTPS) to monitor their accounts and ensure that timely tax payments are being made.

You may contact applicable state and federal tax and unemployment insurance authorities using the following methods:

Federal Tax Payments (through EFTPS)

To verify your IRS payroll tax payments via the Internet:

Your company must be enrolled as an EFTPS user. Go to www.eftps.gov and follow the instructions there or call EFTPS Customer Service at 1-800-555-4477 for an Enrollment form.

To verify your IRS payroll tax payments via the telephone:

Call 1-800-555-4477

Press “0” to speak to a customer service representative.

Maine Tax Payments

To verify withholding tax payments:

Call (207)-626-8475 for Maine Revenue Service.

Press 1 (for touch tone service or stay on the line to speak to a representative).

Choose Option 4 to speak to a representative.

Maine Tax Unemployment Contribution Payments

To verify unemployment tax payments via the telephone, email or the Internet:

1) Call (207)-621-5120 for Maine Department of Labor and ask for the Contribution Unit;

2) Email your request to division.uctax@Maine.gov; or

3) Enroll as a ReEmployME user. Go to www.maine.gov/reemployme and follow the instructions there. You will need to create a ReEmploymentME account and login at the EMPLOYER LOGIN in order to verify payments history.
